## Rules and Regulations:

1. Entry Fee: \$45.00-10'x10' Space; \$55.00-10'x20' Spaces. This form must be turned in by September 1<sup>st</sup> .
2. Entrants will furnish their own setups.
3. Electricity (110 Outlets only) for your booth will be \$10.00 extra
4. **C.H.F. committee reserves the right to sell all beverages.** Vendors will not be able to sell or distribute any beverages at the festival. C.H.F. reserves the right to remove vendors without refund of entry fees.
5. Vendor must list everything you intend to sell. Vendor will be held to the list and can only sell the items on the list. C.H.F. reserves the right to limit vendor items for sale.
6. C.H.F. will not reserve a current space for vender but will take requests. Vendors will set up by 8:00 a.m. and remain open until 5:00 p.m. We are looking for some food vendors who wish to be open past 10:00 p.m.
7. **All food vendors must meet the Temporary Food Service Establishment Permit Requirements of the Waco-McLennan County Public Health District and Compliance Guidelines. Food vendors will be under the control of the festival Health Officer. Health Officer has the right to stop the sale of food items and can and will close a booth for any violations. No Refunds.**
8. If you do not have a trailer as your set-up you will use a tent.
9. A Vendor must have a 2A10BC fire extinguisher. Extinguisher must be in conspicuous location and away from burns and ovens in booth. Please use all your cooking heat equipment with care.
